Facing tumultuous times, universities have adjusted admirably to the unknowns. However, while they are embracing a return to routine, with students and staff predominantly coming back to campus, they continue to face a host of challenges.

Declining enrollment is a top concern

One of their most pressing concerns—declining enrollment—is increasingly addressed by growth in hybrid and distance learning, prized by nontraditional students for its flexibility and by traditional students seeking to blend experiences. One recent study found that **61% of online learners** would choose an online program at a different university before enrolling in an on-campus program. Another study found that **73% of college students** would like to take some fully online courses in the future.

Higher ed institutions are also focused on providing an experience that promotes equality among their students, notes Jordan Adair, Vice President of Product for Honorlock, a company providing on-demand **online exam proctoring services** that blend AI software with live proctors for a human touch. "When some learners are in a remote environment, you can't be sure your students are all on equal footing as easily as when they are all on campus," said Adair.

A key issue is academic integrity

"The school's ultimate goal is to make sure students trust they're on a level playing field. When they're taking an exam, they shouldn't feel the pressure that arises when they think other students in their class might be engaged in something dishonest," Adair said.

Online proctoring is a proven solution

Universities eager to address these various issues can turn to a helpful innovation. Online proctoring offers distinct benefits to five key groups:

- Students
- Instructors
- Distance learning directors/eLearning faculty
- Testing center directors
- Administration

How Online Proctoring Benefits Students

Creates an equal playing field

Protecting the integrity and creating a fair testing experience was a top concern for Peter Burrell, assistant professor for business-related graduate and undergraduate courses at the University of Cincinnati. Like many instructors, he found himself leading a class in March 2020 that had started in person but abruptly moved online. That's when he discovered the importance of an online proctoring platform and began using Honorlock, which was already integrated with his university's **learning management system**, Canvas.

Burrell decided to rely on online proctoring after discovering some students intended to circumvent the test by organizing group chats. After one short training program, he deployed Honorlock and defused the situation, turning him into a firm believer in the technology.

Rooting out academic dishonesty has to be the cornerstone of creating the level playing field everyone seeks. Burrell indicates this is especially true for engaged students. "If I had a really hard professor and I was able to succeed on a test, I felt good about myself. I want my students to experience that sense of achievement," he said, adding that online proctoring supports this goal.

Adair agrees that students become discouraged when they know others around them are trying to beat the system. Their peers' dishonesty can also hurt them if the course is graded on a curve, as it can potentially spell the difference between a passing or failing score.

Provides schedule flexibility

Since it's available 24/7/365, **online proctoring** also allows students to experience the flexibility of taking a test at a time best for them, often without needing to set an appointment at a testing center.

Additionally, there are associated cost benefits for students, given that remote education typically costs less than in-person learning. Yet, the proliferation of virtual learning can come with a downside if it isn't valued as highly as in-person learning, and students don't want the perceived value of their degree to fall if they elect to take a class remotely. "Prioritizing adequate protections for remote testing through online proctoring confirms that an online degree holds the same weight as one where students took the classes in person," said Adair.

Helps reduce student test anxiety

Finally, according to its **student survey**, Honorlock has found that the right online proctoring platform can help ease online text anxiety, which is present in 64% of students. Several safeguards Honorlock offers helped significantly, such as dispelling misconceptions about what could trigger a red flag and the ability to troubleshoot and alleviate technical concerns before starting the test. Honorlock's full-time live proctors are trained to spot physical movements that might indicate anxiety, such as lip licking or touching the face, and they proactively interact with affected students using a reassuring set of talking points. Fully **100% of students** who interacted with a remote proctor said the interaction made them less anxious.







How Online Proctoring Benefits Instructors

Promotes more time teaching, less time testing

Any instructor will lament that there's never enough time to cover all the material they'd like to present, which is why they value online testing's ability to preserve educational hours. However, today's educators are also often overrun with technological expectations, so it's vital that an online proctoring program be simple to deploy. Honorlock integrates seamlessly into a school's learning management software (LMS), so instructors can design the exam as they normally would and choose the proctoring settings they want. Burrell confirms that Honorlock makes it easy for him to administer a test. Saves time and protects academic integrity

Instructors spend a lot of time creating exam content and it's extremely frustrating when that content is shared on the internet. To help protect exam content, **Honorlock's Search & Destroy technology** searches the web to identify exam questions that have been shared online, which allows instructors to take action to send content takedown requests and update exam questions.

Instructors also appreciate that online proctoring ensures the integrity of exam results. Features of solutions like Honorlock include the ability to detect cell phones and other devices, as well as commands like "Hey, Siri."

Provides insight into student behavior

Honorlock's remote proctoring software collects extensive data during the exam and provides actionable reports and time-stamped recordings within the LMS dashboard. This means the instructor can save time by focusing on relevant student behavior and violations.

The exam reports appear in an easy-to-read format that includes relevant student activity such as violations and any suspicious behavior. **University of Florida Lecturer**, Ryan P. Mears, Ph.D., finds Honorlock to be more than a tool to guard or block students from using inappropriate information. "It was also a means to detect and determine many different ways that students approach the exams," he said. How Online Proctoring Benefits Distance Learning Directors and eLearning Faculty

Providing more services with the same faculty

As schools are expanding their ability to serve remote students, that obligation has largely fallen to the already-taxed eLearning unit. However, many distance learning faculty are taking on more responsibilities with the same cohort. That's why a simple implementation is so valuable to educators. Implementation should take days, not weeks, and Honorlock makes it easy, said Adair. "From setting up the LMS integration in as little as an hour to a fully managed implementation and training plan, schools are ready to go."

Securing student data

Distance learning teams are concerned with far more than logistical issues. One key consideration for eLearning faculty is the importance of **protecting students' data**. "Colleges value the fact that we are FERPA-compliant and use an encrypted and secure connection during each online proctored exam," said Adair. "Additionally, all student data is secured and stored on the cloud in an Amazon (AWS) data center which is SOC 3 certified, U.S. Privacy Shield and General Data Protection Regulation (GDPR) compliant.

Ensuring inclusion and accessibility

In addition, distance learning directors and educators are responsible for creating an **inclusive online learning environment** that's accessible and usable for all students, regardless of their disability or condition. Honorlock allows your faculty to provide a variety of accommodations to meet student accessibility needs, such as providing breaks and extending time limits and allowing multiple attempts. Finally, as eLearning departments confront attendant budgetary considerations, some solution providers, such as Honorlock, offer a flat-rate cost per online exam or per student, which helps them better estimate testing costs.

An online proctoring service has to be user-friendly for both the faculty designing tests and the students taking them.

"The acceleration in technology adoption has created new burdens for IT departments because institutions, administrators, and instructors have had to adapt to a suite of new tools at such a fast pace," said Adair. He notes that personnel typically would have several months for training and preparation, adding, "The importance of turnkey software has been brought front and center as they want to streamline offerings and avoid spending extra training dollars or time." Reducing testing review time

Testing center staff typically devote half of their time to administering exams in person and half to reviewing online proctoring sessions to shift some of the workload from instructors, Adair said. Honorlock's configuration helps them quickly identify which batches of student exams they might want to review, eliminating the need to monitor as many sessions and making it more likely they will be able to flag problems.

Providing students with an easy-to-use platform

When technology is easy for students to use, <u>faculty reap the benefits</u> through fewer questions and less hassle with technical issues.
